Healthcare Accreditation

Healthcare accreditation is an official recognition that a healthcare facility – such as a hospital, medical center, or clinic – meets defined standards of quality and patient safety.

In Saudi Arabia, this process is carried out by an independent national body called the Saudi Central Board for Accreditation of Healthcare Institutions (CBAHI).

CBAHI conducts structured assessments that include document reviews, staff interviews, on-site visits, and tracer evaluations to ensure that healthcare organizations follow safe, effective, and organized practices
